## 1. Colorado Cave Survey Data Files Committee (C. Bern, M. Morey)

a. Colorado Cave Surveyor Database (S. Marlatt)

Data collected on 69 caves. DB includes records on almost 500 surveyors.

b. Colorado Cave Ownership Database (R. Rhinehart)

Had initial contact with the managers of the Rifle Falls State Park in early October.

- \* Should we consider re-allocating trips?

Currently: 10/year = 2/grotto (FRG, NCG, CG, SCMG, TG)

Propose: 10/year = 1/grotto (FRG, NCG, CG, SCMG, TG, CWSG, RCG) + 3 open Note – we didn't get anywhere near 10 trips in 2007.

#### 3. Fly & Marble Caves (R. Rhinehart)

- \* There are 245 signed waivers on file (and two unsigned waivers).
- \* Most common cities listed for the contact --

Colorado Springs Metro – 101, Denver Metro – 4, Pueblo Metro - 14

- \* There are a significant number of out of state emergency contacts include in the list, but this probably is misleading, in that parents are often noted as the contact.
- \* Statistically few cavers from north of Colorado Springs or from western Colorado are currently included in the waiver list.
- \* Interestingly, numerous minors are included in the waivers, suggesting these caves are appealing to parents with children. This may be a result of the Cave of the Winds greatly restricting access to minor cavers in recent years.
- \* The installation of registers in the entrance chambers of both caves will be helpful in better tracking trips. My records of scheduled trips since January 1, 2007 indicate 22. Other cave

access reps undoubtedly have scheduled trips, too, of which I do not have a record. Registers will allow for better tracking of trips, as well as provide additional statistical information, such as the length of trips underground and the total number of persons participating. The Survey should act on building and installing such registers prior to the beginning of the new year.
